

ACTIVITY RISK ASSESSMENT for Suzanne Adamthwaite BHSAI INT.T – HORSE ASSISTED THERAPY

Location: Fielden Court equestrian facilities, Lower Gravenhurst, Bedfordshire, MK45

Introduction and general arrangements:

I carried out a formal Activity Risk Assessment of the equestrian facilities at Fielden Court as preparation for the planned delivery of Horse Assisted Therapy sessions to the Equine Assisted Growth and Learning Association (EAGALA) model.

The proprietor, Suzanne Adamthwaite, is registered as an Assistant Instructor with the British Horse Society and is a Certified EAGALA Equine Specialist. With continuous equine experience since childhood, and with over thirty years regular and current practice as an Instructor, Suzanne has a massive reservoir of experience to call on in leading Horse Assisted Therapy sessions. She is also a trained First Aider and keeps a well-stocked First Aid kit and Accident Book on site.

Situated in open countryside with views to the nearby Chiltern Hills and with parking facilities, Fielden Court's equine facilities comprise a fully fenced outdoor school with soft riding surface and a stable block which provides covered areas for sheltered dialogue.

Suzanne's clients will include individuals with learning difficulties, behavioural/addiction issues and other mental health concerns. Clients will always be accompanied by an EAGALA Certified Mental Health Professional (therapist). Client family member(s) may also be present.

Whilst Horse Assisted Therapy sessions are taking place, Suzanne Adamthwaite will focus on the horse(s) in her role as Equine Specialist. An EAGALA Certified Mental Health Professional will always be present during client sessions.



Risks and controls arising from the location:

The yard area is open and uncluttered, giving a feeling of space and calm. With stables, storage and workshop areas and additional covered space alongside an outdoor schooling area and paddocks, the facility is accessed from the adjacent lane. The whole area is flat and level and the school is fully fenced being accessed through a standard self-locking gate.

Routinely kept clean, with walking surfaces swept at least daily, the location presents few risks to health and safety for those familiar with the equine environment. Suzanne Adamthwaite (SA) will always be present whilst Clients are within the facility.

<ul style="list-style-type: none"> • Rakes, shaving forks, pitchforks, hoof picks, scissors and other sharp or bladed tools • Vehicles and machinery including cars, tractors, chainsaws and strimmers • Hoses, lead ropes and baling twine 	All	<ul style="list-style-type: none"> • SA will ensure that all sharp or bladed items will be safely stored out of sight in advance of each client session • SA will ensure that keys for all vehicles and machinery are to be removed from vehicles/machines when “parked” or otherwise not in use • SA is to prevent access to portable petrol/diesel powered equipment. Towed items, such as harrows, are to be kept away from the learning environment • Prior to each client session, SA will ensure that hoses are coiled or put away, lead ropes that are not needed are stored and that lengths of baling twine are cleared away 		
Fire in stable or storage areas/yard	All	<ul style="list-style-type: none"> • SA will ensure that the site is at all times managed as a “No Smoking” zone • SA is to ensure that clients are kept away from dry-stored goods such as hay and straw • SA will include details on Fire Emergency procedures during site induction • SA will provide and maintain one or more Fire Extinguisher(s) in a readily accessible position 		

Risks and controls arising from the clients:

It is recognised that Clients will include individuals with learning difficulties, behavioural/addiction issues and other mental health concerns and that, as a result, their behaviour may at times be unpredictable. Whilst difficulty in managing situations is not expected, behavioural issues of particular concern would include violence towards persons and/or horses, argument and confrontation towards persons and vandalism/destructiveness towards the premises and/or facilities.

Client "needs" to smoke	All	SA is to direct client and accompanying Therapist to a "safe" area away from yard buildings and flammable materials		
Client welfare	Client	<ul style="list-style-type: none"> SA to keep available a supply of potable water and plastic cups/glasses for Client refreshment SA to make emergency toilet arrangements available within the context of what is "reasonably practicable" for an equine facility 		
Client demonstrates unacceptable behaviours before a session commences or begins unacceptable behaviours during a session	All	<ul style="list-style-type: none"> SA to discuss approach with the accompanying Therapist, with options to include delaying, adjusting the content of, or abandoning the session SA is to ensure that a mobile phone or other contact mechanism is available at all times to call for appropriate support or the emergency services SA is to have available at all times during a session, an appropriate number of head collars and lead ropes such that the horse or horses being used can be readily separated from the client(s) SA to have the option to refuse future attendance of individual clients as circumstances dictate 		
Client attends site, or returns to site, unaccompanied by a Therapist and outside of agreed session times	Client and SA	<ul style="list-style-type: none"> SA to maintain contact details for Therapists and other relevant support as a readily accessible hard-copy list within the stable yard and/or within her mobile phone SA is to ensure that a mobile phone or other contact mechanism to call for appropriate support or emergency services is available at all times 		

Risks and controls arising from the horses:


EAGALA practice requires that horses are not ridden during client sessions and all client/horse interfaces are therefore ground based. No whips are used or available during sessions and horses are generally loose, unencumbered by head collars.

Inappropriate horse(s) selected for client sessions	All	<ul style="list-style-type: none">SA is to ensure that generally calm, well and mature horses are deployed for each client sessionIn the event of unavailability of suitable horses, consideration must firstly be given to abandoning a session rather than to deploying an unsuitable replacement animalUnwell or lame horses must not be deployed		
Horse is "spooked", leading to an unpredictable response	All	<ul style="list-style-type: none">SA is to have available at all times during a session, an appropriate number of head collars and lead ropes such that the horse or horses being used can be readily separated from the client(s) and TherapistSA is to ensure that a mobile phone or other contact mechanism is available at all times to call for appropriate support or the emergency services

With thoughtful session planning and careful management of the identified risks in line with the detail in the above texts and tables, I am confident that Horse Assisted Therapy sessions to the EAGALA model can be safely conducted at this venue.
